We also are pleased to offer discount fares for your rides if you are over 60 years. (See the fare schedule and use the Senior column for determining your fare.)

Handicap Assistance: The Red Cliff Transit and all BART buses are equipped with a wheelchair lift. 2. Do not have distracting conversations with the bus operator.

4. No personal errand stops are allowed, once you leave the bus you pay a new fare."
